Member state representatives endorsed the proposal on Friday, paving the way for it to be approved by ministers when they meet on May 26.

Consumers with subscriptions to services such as Sky TV Now, ProSiebenSat.1Max-Dome TV in Germany or Netflix in France, would be able to view content they have paid for when they temporarily travelabroad.

What constitutes temporarily was left open, but member states specified that it is a "limited amount of time". The EC hopes that the proposal will enter into force in 2017, the same year that roaming charges for using mobile phones when travelling within the 28-member European Union are supposed to be abolished.

Knocking down barriers to a single market in both the online and offline worlds is a key aim for Brussels, and letting people take online subscriptions abroad is reminiscent of its efforts to allow use of domestic mobile phone subscriptions abroad without paying hefty roaming charges.

While Netflix is already available in many European countries, content is tailored tolocal tastes, so a French user in Belgium, for example, will not have access to the specific French catalogue without using workarounds such as virtual private networks.

The proposal got a lukewarm reception from broadcasters and in December, some of whom are concerned producers and film studios could demand more money for making their content portable.

Rights-holders are wary of anything that might be seen to beerodingtheprinciple of territoriality, which they say is key to the financing of films.
