We have reviewed the accompanying Statement of Consolidated Unaudited Financial Results ("the Statement") of Orient Bell Limited ("the Company") and its share of the net profit after tax and total comprehensive income of its associates for the quarter ended December 31, 2019 and year to date results for the period from April 01, 2019 to December 31, 2019, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the Regulation"), including relevant circulars issued by SEBI from time to time ("the Circulars").  of Indian Accounting Standards ("Ind AS") as specified in section 133 of the Companies Act,2013 read with Rule 3 of
 Companies (Indian Accounting standards) Rules,2015 and relevant amendments thereafter.
- 2. The above financial results have been reviewed by Audit Committee and thereafter approved and taken on record by the Board of Directors in its meeting held on January 30, 2020. These financial results have been limited reviewed by the Statutory Auditors of the Company. As the company did not opt consolidation of results for the corresponding quarter and the corresponding year to date ended on December 31, 2018, as reported in these financial results, have been approved by the board of directors of the respective companies but have not been subjected to limit review by the statutory auditors of the Company.
- The Company has adopted Ind AS 116 'Leases' with the date of initial application being April 1, 2019, using the modified retrospective method. The Company has applied the standard to its leases with the cummulative impact recognized on the date of initial application (April 1, 2019). Accordingly, previous period information's has not been reinstated.
- 4. The business activity of the Company falls within a single primary business segment viz. 'Ceramic Tiles and Allied Products' and hence there is no other reportable segment as per Ind AS 108 "Operating Segments".
